LJDWEEK2018 BY THE NUMBERS



On November 5th, the World Bank hosted 1,300 attendees to the annual event Law, Justice and Development Week in conversations on how law and legal tools can help best tackle today's development challenges. The event featured 186 speakers, and gathered for the very first time 30 Ministers of Justice, Chief Justices and Judges from around the world and highlighted the critical link between law and justice to international development work.

LJDWeek2018 reiterated that well-functioning laws, judicial institutions and governments bound by the rule of law are key to every country's economic and social development. With the upsurge of areas afflicted by fragility and conflict, and the number of migrants, refugees and internally displaced persons, this year's focus on rights, protection and development looked at how to best uphold rights and guarantee protections to those who need it the most, and how international development agencies can help promote security, safety and opportunities for empowerment for everyone to grow into their best potential.
